PUBLIC PATH DIVERSION ORDER 2025

This Order is made by Leicestershire County Council ("the authority") under Section 119 of the Highways Act 1980 (hereinafter called "the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath and described in paragraph 1 of this Order it is expedient that the line of the footpath should be diverted.

Harborough District Council has been consulted and has consented to the making of the Order as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over the land situated at Chestnut Farm, Burton Overy and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 30 days from the date of this Order.
2. Notwithstanding anything contained in paragraph 1 where immediately before the date on which the public right of way referred to therein is diverted in pursuance of this Order, there is apparatus on, under or over the right of way belonging to statutory undertakers, for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

3. There shall at the end of 30 days from the date of confirmation of this Order be a public footpath over the land at Chestnut Farm, Burton Overy described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
4. Notwithstanding the provisions of Article 1 these provisions for the extinguishment of the public right of way shall not come into force until the Leicestershire County Council acting by its proper officer shall have certified that the agreed works have been carried out to its satisfaction in accordance with Section 119(3) of the 1980 Act.
5. This Order may be cited as the "Leicestershire County Council (Public Footpath C7 (Part) at Chestnut Farm, Burton Overy) Public Path Diversion Order 2025."

SCHEDULE

PART I

DESCRIPTION OF SITE OF EXISTING FOOTPATH C7 TO BE DIVERTED

That part of Footpath C7 at Chestnut Farm in the Parish of Burton Overy and the District of Harborough, shown by a bold continuous line on Plan No. 2640 annexed hereto, which extends from point "A" on the plan, situate at its junction with Carlton Lane at Grid Reference 46842 29783 in a generally south-easterly direction through two agricultural buildings and across a large open field, for a total distance of approximately 670 metres to point "B" on the plan situate at a footbridge over the Burton Brook at Grid Reference 46897 29745. (A-B as indicated on the plan).

The section of footpath to be diverted has no recorded width.

PART II

DESCRIPTION OF SITE OF NEW FOOTPATH C7 TO BE CREATED

A new footpath (C7) at Chestnut Farm in the Parish of Burton Overy and the District of Harborough, shown by a bold broken line on Plan No. 2640, annexed hereto, which extends from point "C" on the plan situate at its new junction with Carlton Lane by the entrance to Chestnut Farm at Grid Reference 46846 29782, in a generally south-easterly direction along the north-eastern boundary of a large field for a distance of approximately 620 metres to point "D" on the plan situate at the field's north-eastern corner at Grid Reference 46899 29749 and then continues in a generally south-westerly direction alongside the Burton Brook for a further distance of approximately 40 metres, to point "B" on the plan previously described. (As depicted C-D-B on the plan).

The new footpath will have a width of 2 metres.

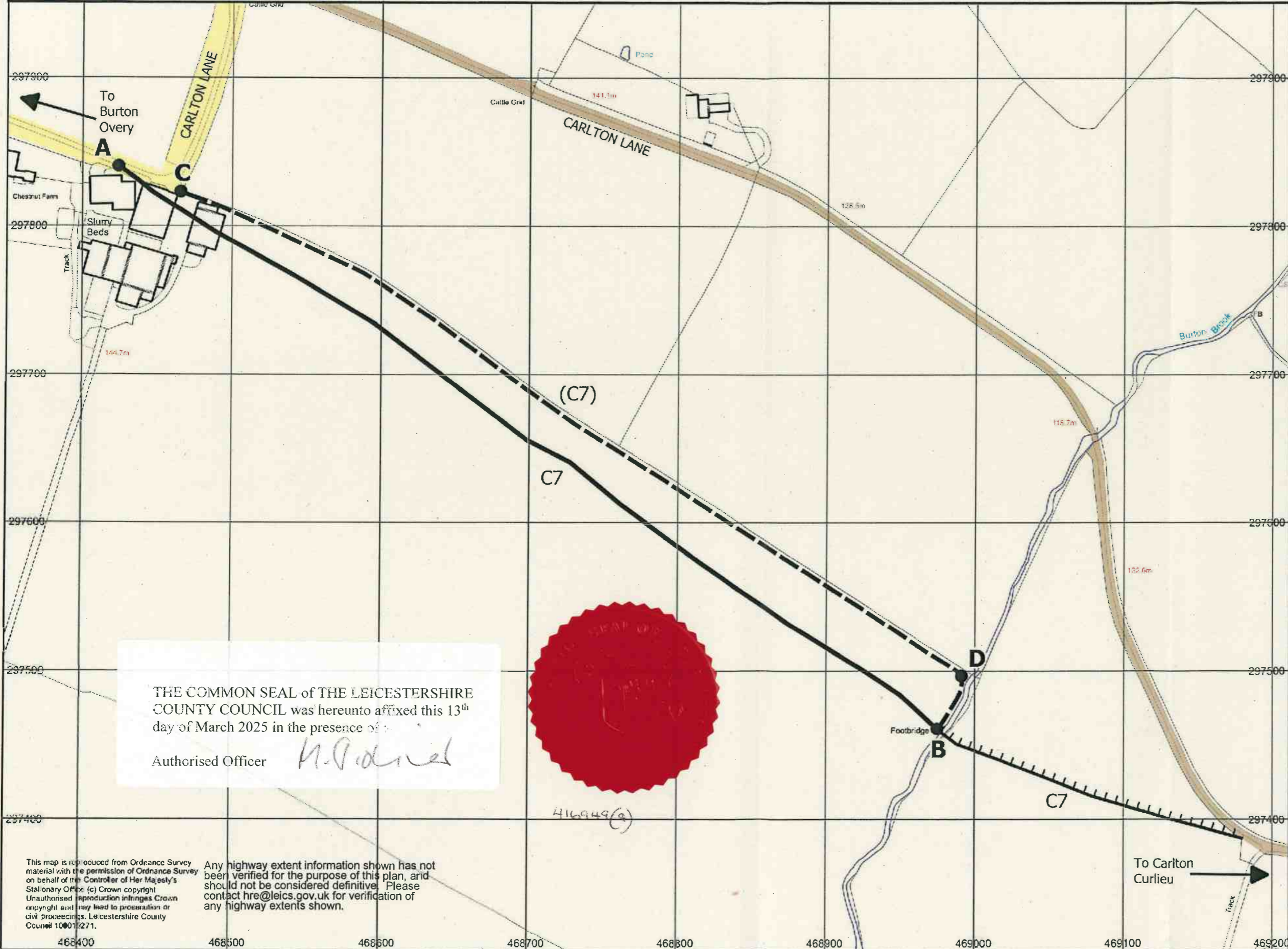
