Working with retail groups, businesses, the county council, and other organisations, Harborough District Council has put in place, very quickly, a number of measures to create a safe environment for shoppers to ensure that businesses could reopen safely.

Town centres 'open for business' with safe shopping measures in place

Shops and businesses are **'open for business'** across Harborough district following the Government's easing of the national lockdown – and more businesses are set to reopen in July.

Harborough district is **not** affected by the Leicester lockdown imposed this week and our shops remain open for trade. More information about the Leicester lockdown, and affected areas (with a handy postcode checker), can be found on our website here.

In Market Harborough and Lutterworth; 'Highstreet Helpers' (pictured) wearing high-visibility vests, are helping guide shoppers in our town centres; there are also public hand sanitiser stations in high streets, and street markings to show people where to queue.

The **public toilets** in the Commons car park in Market Harborough, are open with additional cleaning arrangements in place, new signage, and staff on hand to allow one person in at a time. We have also opened our public toilets in Welland Park and Little Bowden Recreation Ground.

To create a safer pedestrian environment, temporary **road closures** have been introduced in collaboration with Leicestershire County Council, Lutterworth Town Council, retail groups and local businesses.

These apply to Adam and Eve Street, and Church Street (pictured) in Market Harborough, and in Church Street in Lutterworth. These road closures will be monitored and reviewed on an ongoing basis.

We are also working with local businesses following further Government announcements this week that hairdressers, hotels, pubs and other businesses in England can from 4 July 2020 and how they can do this safely.

We are also working on a **'shop local'** campaign to encourage people to support their local shops, and markets, at this time.

In line with businesses opening, Harborough District Council will look to re-instate **car parking charges** at all Council-owned car parks across the Harborough District, over the coming weeks, but with some changes. Details will be shared publicly once a date is agreed. Parking restrictions continue to apply at onstreet locations in town centres.

The episodes, which are each approximately seven minutes long, cover a range of topics including, flytipping management, virtual planning meetings, increased safeguarding and local food banks.


They include interviews with council colleagues who have been redeployed from their usual roles to support the evolving needs of people across the district.

Plea to use parks responsibly as action taken on litter and disorder



A joint patch walk and extra patrols are among the actions taking place to tackle recent anti-social behaviour at a park in Market Harborough.

Harborough District Council, Police, Leicestershire Fire, and Leicestershire County Council have joined forces as part of a proactive response to anti-social behaviour at Little Bowden Recreation Ground including public disorder, rowdiness and littering.

There will be a multi-agency patch walk, as well as extra patrols of both police and council officers. Further signage and security measures are also being looked into.

Extra bins have been provided and fines of £150 will given out to those caught littering.

A letter is being sent to residents, living close to the recreation ground, to update them on steps being taken.

Farmers market set to return to town centre with new measures in place



The popular Farmers Market will return to The Square in Market Harborough on Thursday 2 July 2020, from 9am to 3pm.

The monthly market had been stopped due to the coronavirus pandemic but will restart with new safety measures in place.

Social distancing measures will be introduced, which includes fencing of the Square to create a one-in, one-out queuing system at entry, a revised layout and hand sanitiser stations in place.

Sit down seating will not be available, and shoppers will be asked not to touch produce without buying and are encouraged to pay by card.

The return of the Farmers Market follows the full reopening of the indoor market hall.

Council's customer services reopening for appointments only

We will reopen the Council's customer services at The Symington Building for essential enquiries from week commencing 13 July 2020.

This will be by appointment only.

Appointments will be offered on a Monday and Wednesday between 10am-12noon and 1pm-4pm.


There will be no internal seated waiting area and, to limit access to the building, only one customer per enquiry will be allowed unless the customer is vulnerable or exceptional circumstances apply.

Only customers with a pre-booked appointment will be able to see a customer services advisor – our walk-in service is **not** available. Once entering the Customer Services area you will be required to follow the signage and support the 2m social distancing.

Hand sanitising station will be available on entering the building which customers will be required to use.

From 9 July 2020, customers will need to call 01858 8282828 number and select the option for an appointment, or they can make an appointment online at www.harborough.gov.uk/f2fappointment

An adviser will see if they can deal with the enquiry over the phone and if not the customer will be invited in for an appointment. Payments payments for services will not be taken through the appointment service.



To ensure the number of people in the building is kept to a minimum, the public access PCs are not available and there are no toilets available for use by the public.

Our Customer Service Advisors have been supplied with PPE including face coverings, gloves and hand sanitiser for their personal use, and our customer services desks have been fitted with plastic screening. We will also be carrying out cleaning on a regular basis to help reduce the risk of infecting others.

A campaign which has dramatically reduced flytipping in the Harborough district and led to a number of prosecutions and fines for culprits has been has nominated at the National Recycling Awards 2020.

Our Tip Off campaign has been shortlisted in two categories - 'Campaign of the Year' and 'Local Authority Success'.

It comes as the Council announces a double success after a man who dumped rubbish in a lane in the Harborough district was caught on CCTV and fined – along with the householder who paid him to remove the waste.

Householders and businesses are reminded that they legally responsible for any waste produced on their property. They have a 'duty of care' to check that any person or business disposing of their waste is legally allowed to do so and can do this on the Environment Agency website.

We have also just launched banners on some of our refuse collection vehicles which read: "Fly-tippers beware - we are watching you."
